

procurement team not asking for it. Consistency. Knowledge and capacity within suppliers

Haven't yet worked out exactly what we want to ask (ie. just their scope 1 and 2, or should we include some of their scope 3?)

Effective contract management, available resource, internal engagement



What barriers are you facing in getting carbon data from suppliers?



Internal capacity to check/validate data. SME suppliers limited capacity to provide it. Difficulties around carbon factors for provision of services rather than goods.

Knowing what to ask and they understanding how to find the data.
